RECOMMENDING THE AWARD OF CONTRACT THROUGH ALTERNATIVE METHOD OF PROCUREMENT -SMALL VALUE PROCUREMENT TO THREESIXTEEN SPECIALIZED GOODS TRADING, BAGUIO CITY FOR SUPPLY AND DELIVERY OF ID MATERIALS TO PINES CITY NATIONAL HIGH SCHOOL, BAGUIO CITY

WHEREAS, there is an approved Purchased Request (PR) No. 2025-07-06 dated July 29, 2025 with cost of SEVENTY-FOUR THOUSAND TWO HUNDRED EIGHTY PESOS only (Php74,280.00) for the procurement of materials for Schools ID of Learners for SY 2025-2026 to Pines City National High School, Baguio City;

WHEREAS, (PR) No. 2025-07-06 with an estimated costs of SEVENTY-FOUR THOUSAND TWO HUNDRED EIGHTY PESOS only (Php74,280.00) involves Small Value Procurement under Sec. 53.9 of the Revised Implementing Rules and Regulations of A 9184, and therefore falls under the Alternative Mode of Procurement Method;

WHEREAS, the PCNHS BAC thru its Secretariat has requested for submission of Price Quotations on the said Purchase Request and has obtained three (3) price quotations from legitimate suppliers, as follows:
