RECOMMENDING THE AWARD OF CONTRACT THROUGH ALTERNATIVE METHOD OF PROCUREMENT -SMALL VALUE PROCUREMENT TO MICROMEDIA TECHNOLOGIES, BAGUIO CITY FOR SUPPLY AND DELIVERY OF IT EQUIPMENT TO PINES CITY NATIONAL HIGH SCHOOL, BAGUIO CITY

WHEREAS, there is an approved Purchased Request (PR) No. 2025-08-12 dated August 20, 2025 with estimated cost of ONE HUNDRED TWENTY- NINE THOUSAND & FIVE HUNDRED PESOS only (Php129,500.00) for the procurement of IT EQUIPMENT to Pines City National High School, Baguio City;

WHEREAS, (PR) No. 2025-08-012 with an estimated costs of ONE HUNDRED TWENTY-NINE THOUSAND & FIVE HUNDRED PESOS only (Php129,500.00) involves Small Value Procurement under Sec. 53.9 of the Revised Implementing Rules and Regulations of A 9184, and therefore falls under the Alternative Mode of Procurement Method;
