**RECOMMENDING THE AWARD OF CONTRACT THROUGH ALTERNATIVE METHOD OF PROCUREMENT -SMALL  
VALUE PROCUREMENT KINGBOODLE FOODGASM SIZZLING HOUSE, BAGUIO CITY FOR CATERING SERVICES TO  
PINES CITY NATIONAL HIGH SCHOOL, BAGUIO CITY**

WHEREAS, there is an approved Purchased Request (PR) No. 2025-05-01 dated May 7, 2025 with estimated cost of EIGHTY-FIVE THOUSAND & TWO HUNDRED PESOS ONLY (Php85,200.00) for catering services to Pines City National High School, Baguio City;

WHEREAS, (PR) No. 2025-05-01 with an estimated costs of EIGHTY-FIVE THOUSAND & TWO HUNDRED PESOS ONLY (Php85,200.00) involves Small Value Procurement under Sec. 53.9 of the Revised Implementing Rules and Regulations of RA 9184, and therefore falls under the Alternative Mode of Procurement Method;
