




CONTRACT OF AGREEMENT

THIS CONTRACT, made and entered into this 20th day of May 2025 **between PINES CITY NATIONAL HIGH SCHOOL**, Baguio City locate at Palma Street, Baguio City represented herein by its Principal, **DANILO P. GAYAO**, hereinafter referred to as the "**Entity**" **THE STABLE EDUCATIONAL SUPPLY** represented herein by **MARCH WELDON O. MA** hereinafter referred to as the "**Supplier**";

WHEREAS, upon the invitation of the Entity, the Supplier submitted a bid for the procurement of IT Equipment to Pines City National High School, Baguio City in the amount of EIGHTY-FOUR THOUSAND PESOS ONLY (Php84,000.00) inclusive of appropriate taxes and fees (hereinafter called) the "Contract Price", which the entity subsequently accepted pursuant to PCNHS BAC Resolution Number 27, s. 2025;

NOW THIS AGREEMENT ITNESSETH AS FOLLOWS:

- a) The supplier complies with the documentary requirements as an accredited supplier in accordance with the provisions of RA9184 and applicable laws, rules and regulations;
 - b) The **Entity's** Terms of Reference (PO), attached as **Annex A**;
 - c) The **Supplier's** quotation, attached as **Annex B**; and
 - d) The **Entity's** Notice of Award, attached as **Annex C**.
- 1) In consideration of the payment to be made by the **Entity** to the **Supplier** as herein before mentioned, the **Supplier** hereby covenants with the **Entity** to provide the goods listed in the Purchase Order, in good condition and warrants the same for any defective items for replacement. Changing of item is upon the approval of the Head of the Procuring Entity.
 - 2) The **Supplier** shall pay appropriate taxes in full and on time and that failure to do so will entitle the government to suspend payment for any services delivered by the **Supplier**.
 - 3) In no circumstance/s, shall the supplier release the equipment/supplies/materials/goods to any unauthorized personnel except for the members of the inspection committee of the entity and duly designated personnel during weekdays (office hours) only;
 - 4) In all circumstances, the supplier shall act in the best interest of the entity and shall not offer direct or indirect benefit to any official of the entity or engaging misinterpretation or concealment of any trade commission, fee, discount and other practices or acts of graft and corruption;
